

INSTRUCTIONS FOR PROTECTED PERSON IF RESTRAINED PERSON HAS GUNS, FIREARMS OR AMMUNITION

Serving Your Restraining Order

If you believe the person to be restrained has any **guns, firearms or ammunition**, or if the judge marked box #9-c on the form DV-110 Temporary Restraining Order indicating that the person has guns or ammunition, then you should ask the Sheriff to serve your temporary restraining order. (The Sheriff can be reached at: (408) 299-2311 or (408) 299-3233 -- 24 hr. non-emergency dispatch line).

If you do not know where the person to be restrained person lives or works, or how he or she can be contacted, then the Sheriff will not assist you.

Instead, you must arrange for someone age 18 or older, other than yourself, to serve your papers on the person to be restrained. To ensure the safety of the person who serves your papers, you should:

- (1) Inform the person who will serve your papers that the person to be served has **guns, firearms or ammunition**.
- (2) Suggest to the person who will serve your papers they contact the law enforcement agency for the city or town where the papers will be served to ask for help.

After Serving Your Restraining Order

If you believe the restrained person has **guns, firearms or ammunition** that have not been relinquished, sold, or stored as ordered, you may call the law enforcement agency for the city or town where you live to ask for help.

If you have questions, you may go to the Family Court Restraining Order Help Center for assistance.
